

Golf Outing Contract

All Golf Outings are held on Mondays.

There must be a minimum of 75 participants in order to have a golf outing at Spring Meadows Country Club. Events with less than 75 participants must have Management recommendation, as well as, approval by the Board of Directors.

A guaranteed count must be provided to Spring Meadows Country Club one week prior to the event. This is the number you will be charged for. If you have additional people on the day of the event you will be charged for each addition. If you have fewer than your guarantee, you will be required to pay for the number guaranteed since we will have already purchased food and scheduled staff for that day.

Meal selection must be made one month prior to your event. Please discuss your food service requirements with our Food and Beverage Manager, Doug Bosley at (810) 735-7836 ext. 11.

Alcoholic beverages and food/beverages at our Halfway House may be purchased through the sale of tickets.

All food, beverages, and alcohol must be purchased from Spring Meadows Country Club.

Payment for the event is due and payable to Spring Meadows Country Club within five days of the event. There will be no exception to this rule.
